Conditions of Order for FORM 2 / (表格二) 一般守則

- 1) All dimensions are in metre, L=length, W=width, H=height, D=depth.
- 2) In general, orders for the facilities and equipment rental should be submitted to the Official Stand Contractor before the specified deadlines, otherwise a 50% surcharge will be levied for orders submitted **after 12th June, 2025 or on-site (if accepted)**.
- 3) All orders for services, equipment or booth facilities should be submitted with full payment together with any damage / security deposit if necessary. Orders without the required payment(s) will not be entertained.
- 4) All equipment / booth facilities provided by the Official Stand Contractor shall only be utilised within the Venue exclusively for the Exhibition.
- 5) Provisions of any services, equipment or booth facilities by the Official Stand Contractor are subject to their availability at the time of ordering. Orders will be entertained on a "first-come, first-served" basis. However, the Show Organiser and Official Stand Contractor reserve the right not to entertain any orders received and, in such cases, the users will be notified and cheque payment will be returned or refunded.
- 6) If by reason of force majeure, labour difficulties, shortages of materials or any other cause outside the control of Official Stand Contractor who is unable to provide all or any of the services, equipment or booth facilities ordered during the whole or any part of the duration of the Exhibition, hirer's right shall be limited to the return of a corresponding proportion of the charges paid for such undelivered services or equipment or booth facilities.
- 7) Hirer shall be responsible for returning all rented equipment and related materials to the Official Stand Contractor within one hour on the last show day following the close of the Exhibition.
- 8) Hirer shall use the equipment in a careful and proper manner and in accordance with the Rules and Regulations issued by the Show Organiser. Hirer is not allowed to make any alterations, modifications, attachments and / or additions to the equipment / booth facilities rented.
- 9) Hirer shall be liable to any loss or damage to the equipment arising from the hirer's negligence, unintentional act, unauthorised maintenance or other cause within the reasonable control of the hirer, its representative, employees, agents or invitees. In the event of any loss or damage to the equipment for which the hirer is liable, the hirer shall reimburse the Official Stand Contractor for all cost incurred for repair or replacement.
- 10) Hirer shall be in default hereunder if hirer fails to pay any charges when due or any other indebtedness or fails to return the equipment to the Official Stand Contractor after use.
- 11) At any time after the hirer's default, the Official Stand Contractor may terminate the rental services, by notice to hirer and repossess the equipment / booth facilities. Hirer shall remain liable to all unpaid charges and the Official Stand Contractor may apply and retain all or a portion of the hirer's security / damager deposit as may be necessary to compensate the Official Stand Contractor for any unpaid charges or damages and expenses incurred on account of such default; or the Official Stand Contractor may exercise any other rights occurring to a less or under any applicable law upon a default by the hirer.
- 12) Hirer must ensure that the additional bank handling charges are included in the telegraphic transfer payments.

- 6) 如因不可抗力、勞工問題、物資短缺或其他非大會指定展台承建商所能控制的因素，致使大會指定展台承建商不能在展會期間提供已申請租用的部份或全部服務或設施，承租人只會就未能提供之服務或設施按比例取回已繳付的服務或設施費用；而已完成安裝設施和已提供服務的部份將不作退款。
- 7) 承租人須負責在展覽會最後一天結束後一小時內，將所有租用的設施及有關物料交回大會指定展台承建商。
- 8) 承租人必須謹慎而正確地使用有關設施，遵守大會指定展台承建商定下的條款和規則，不得擅自更改設施的結構和用途或增添附加裝置。
- 9) 因承租人的疏忽、非蓄意行為，未經許可的維修或租用者、其代表、僱員、代理人或所邀請訪客在可以控制的情況下對設施造成的損毀，承租人必須承擔賠償責任。大會指定展台承建商因此而需更換設施或作出維修所引致的費用，須由承租人繳付。
- 10) 承租人如未能如期繳款、償付其他欠款或於設施使用完畢後未能交回大會指定展台承建商，一概作違約論。

Booth Layout Plans & Design Proposals

Booth layout drawings, plans and design proposals must be submitted to the Official Stand Contractor for approval **no later than 12th June 2025**. Drawings submitted must be in a scale of not smaller than 1:100 with full dimensions and must contain such information as floor plans, stand elevations, telephone, electrical fittings, colours and materials to be used, audio-visual equipment to be used, etc.

Height Limit

No stand decoration, stand fittings or exhibits shall exceed 4 metres in height, unless prior approval in writing has been sought from the Official Stand Contractor.

Hanging Structures & Trusses

Exhibitors must apply approval from the Show Organiser for hanging structures / trusses. The Official Stand Contractor will permit hanging structures / trusses only with approval.

Exhibitor-appointed Contractor

A Raw Space Exhibitor may appoint any competent local contractors to design and construct its stand. If the Exhibitor appoints an overseas contractor, it is mandatory to comply with the requirements imposed by the Immigration Department of Thailand. Please ensure that the contractor's staffs have valid working visas/permits to work in Thailand. Exhibitors should provide the names of their appointed contractors, contact persons, telephone and address information to the Official Stand Contractor by using Form 4 for approval. The Official Stand Contractor reserves the right to withhold approval to any contractor appointed by the Exhibitors concerned, evaluating their past record in discipline, safety, etc. Exhibitors requiring assistance in appointing contractors for their custom-built stands should contact the Official Stand Contractor directly.
